Assisted local law enforcement with search for a missing male subject that may have committed suicide on back of MHCO farm. I transported 2 officers on our newly donated ATV to investigate a suspicious area they observed with their drone in a heavily wooded area that was unable to be accessed by vehicle. The search yielded negative results and all clear was given. There had been no direct evidence that the subject was ever on our property, but only one of several locations that a relative wanted checked.

Attended Homecoming Security meeting at SJAB with MHCO Administrator, Sheriff Fountain, OPD Chief Ford, OPD Captain Curl and OFD Chief Cottrell.

Attended another security camera meeting at Cobb center with Tenplus, LuAnne, Tabitha and Victor.

Investigated and interviewed a 21-year-old resident of Bundy cottage after receiving a complaint of him smoking marijuana while speeding through campus. A search was conducted with OPD assistance, and he was found to have marijuana blunts with the legal amount of THC and a vape. He was not to possess the blunts on campus, thus they were seized. No charges were filed.

Observed numerous hours of live video footage around campus to assist with safety of residents and staff.

Conducted numerous vehicle and foot patrols of MHCO campus and the farm.
